Dear Mr. Null:

Please find enclosed two copies of the Final Status Survey Report for L Building and the LAR section of B Building at the Aptuit, Inc. facility at 10245 Hickman Mills Drive, Kansas City, Missouri. Aptuit discontinued operations with radioactive materials under U.S. Nuclear Regulatory Commission License Number 24-15595-01 in the subject areas and has completed the radiation survey and site investigation process. This process included the completion of a historical site assessment, a characterization survey, and a final status survey (FSS).

The FSS was performed under the guidance of the Multi-Agency Radiation Survey and Site Investigation Manual (NUREG-1575, Revision 1) and the Consolidated Decommissioning Guidance (NUREG-1757, Volume 2.) The primary purpose of the FSS was to demonstrate that residual radioactivity in each survey unit satisfied the release criteria as established by the U.S. Nuclear Regulatory Commission's license termination rule (10 CFR 20, Subpart E).

Based upon the results of the FSS as described in the enclosed report, Aptuit requests that the study areas be released for unrestricted use and that they be removed from Aptuit's Radioactive Material License Number 24-15595-01.

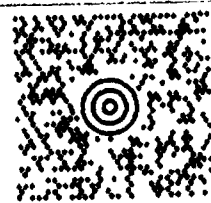

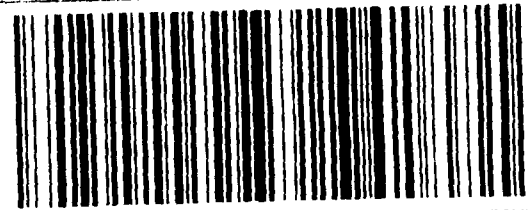
