Dear Mr. Gutierrez:

This letter recaps our phone call of October 31, 2006. In that call, I informed you that the NRC Staff has received a Freedom of Information Act (FOIA) request for many of the exhibits attached to the August 2003, Office of Investigations Report of Investigation (OI Report) into the Davis-Besse head degradation event. I also informed you that the Staff is attempting to comply with this request without inadvertently making public any proprietary documents, but that the Staff was concerned that it had trouble in precisely determining which documents and parts of documents fell under the requests for withholding submitted by FirstEnergy on behalf of itself and certain contractors (Withholding Requests).¹

In the phone call, we agreed that the Staff would mail to you the OI Report exhibits so that a more precise determination of withholding could be made. More specifically, we agreed upon the following: (1) that the "publicly available" documents that the Staff has preliminarily determined not to fall under the Withholding Requests would be reviewed to see if they should be withheld and (2) that the "proprietary" documents that the Staff has preliminarily determined to fall under the Withholding Requests would be reviewed to see if they should not be withheld. The Staff, therefore, is sending to you as enclosures to this letter electronic versions of the OI Report exhibits so that FirstEnergy can make the appropriate determinations. The OI Report exhibits are contained on two CDs, a "publicly available" CD and a "proprietary" CD.

According to our conversation, you will attempt to make these determinations as quickly as you can, coordinating with the different interested parties, and a Morgan Lewis attorney will contact me ten business days from now with either their position on the documents or an update on the progress of the review. In order to expedite FirstEnergy's review, the Staff is also enclosing an index of the OI Report exhibits, which includes the Bates Numbers of the exhibits, a brief document description, and an indication of whether exhibits are proprietary in their entirety. There are documents with proprietary subparts, however, that are not marked proprietary in the indexes.


As for the files, themselves, the filenames of the electronic versions identify the documents either by their exhibit number (e.g., OI Report Exhibit 146) or by their beginning Bates Number (e.g., NRC001-0001). It should be noted that many of the exhibits are comprised of a document with attachments, which can appear as several files on the CD. For example, the

OI Report exhibits index may identify an exhibit as having Bates range NRC005-0001 to 0143, but this could be comprised of seven separate electronic files, with five on the "publicly available" CD and two on the "proprietary" CD.

A related issue, but one not subject to the present FOIA request and not discussed in our phone call, concerns generally the sufficiency of the Withholding Requests with regard to identifications of documents or justifications for withholding. The Staff is reviewing those identifications and justifications and will contact FirstEnergy in the future if the Staff has any issues with them.
