Please terminate our radioactive materials license. As of December 22, 2006, we no longer provided licensed services. All sealed sources will be transferred to a licensed recipient or returned to the manufacturer. Only unsealed materials identified in 10 CFR 35.200 for cardiovascular diagnostic tests have ever been used at this facility; thus no residual contamination remains; however, to maintain strict compliance, closeout surveys will be performed. Upon completion of the closeout surveys, and verification that there is no residual contamination, the facility will be released for unrestricted use.


