3) Transportation and Route Schedule


The vessel sailed from Hamburg, Germany on November 12, 2006. The ocean transportation from Hamburg, Germany to Toronto, Ontario, Canada will be the responsibility of Hapag Lloyd Steamship Line. The vessel will unload at Montreal, Quebec, Canada on or about November 20, 2006. The containers will then transport by rail to Toronto, ON. The containers will enter the USA by road at Buffalo, NY between approx. Nov 30, 2006 and Dec 6, 2006 and continue on to Metropolis, IL. The inland transportation from Toronto ON to Metropolis, IL will be the responsibility of RSB Logistic Services Inc.
