SUBJECT: NEW LICENSE

Please find enclosed License No. 33-29238-01. An environmental assessment for this action is not required, since this action is categorically excluded under 10 CFR 51.22(c)(14)(vi). You should review this license carefully and be sure that you understand all conditions. If you have any questions, you may contact me at 817-276-6552.

The NRC needs your Taxpayer Identification Number in order to make payments (refunds). Please complete and return the self-addressed, stamped NRC Form 531, "Request for Taxpayer Identification Number," which is enclosed for your convenience.

NRC's Regulatory Issue Summary (RIS) 2005-31, provides criteria to identify security-related sensitive information and guidance for handling and marking of such documents. This ensures that potentially sensitive information is not made publicly available through ADAMS. Pursuant to NRC's RIS 2005-31, the enclosed materials license will not be made publicly available.

Please note, License Condition 18 requires implementation of all required orders by the first day that radionuclides in quantities of concern are possessed at or above the limits specified in "Table 1 Radionuclides of Concern", as specified in the *Federal Register* Notice dated December 1, 2005 (70 FR 72128). Within 25 days after implementing the requirements of this license condition, you must notify the Director, Office of Federal and State Materials and Environmental Management Programs, U.S. NRC, Washington, DC, 20555, in writing.

In the event of an emergency or incident involving radiation sources within the jurisdiction of the NRC, please notify local authorities as well as the NRC, as required. You may report any incident to the NRC by calling the Headquarter's Operations Center (HOO), which is staffed 24 hours a day and accepts collect calls, at the number provided below. NRC notification to the HOO is required when licensed material is lost or stolen; when licensed devices are damaged or involved in accidents that result in doses, or may cause or threaten to cause an exposure, in excess of 10 CFR 20.2202 limits. The NRC Headquarter's Operations Center telephone number is 301-816-5100.

NRC expects licensees to conduct their programs with meticulous attention to detail and a high standard of compliance. Because of the serious consequences to employees and the public that can result from failure to comply with NRC requirements, you must conduct your radiation safety program according to the conditions of your NRC license, representations made in your license application, and NRC regulations. In particular, note that you must:

1. Operate by NRC regulations 10 CFR Part 19, "Notices, Instructions and Reports to Workers: Inspection and Investigations," 10 CFR Part 20, "Standards for Protection Against Radiation," and other applicable regulations.
2. Notify NRC in writing of any change in mailing address.
3. Notify NRC in writing of any radiographic operations or storage of radioactive materials at a temporary jobsite for a period in excess of 180 days during a calendar year.
4. In accordance with 10 CFR 30.36(d), notify NRC, promptly, in writing within 60 days, and request termination of the license:
  - a. When you decide to terminate all activities involving materials authorized under the license whether at the entire site or any separate building or outdoor area;
  - b. If you decide not to acquire or possess and use authorized material; or
  - c. When no principal activities under the license have been conducted for a period of 24 months.
5. Request and obtain a license amendment before you:
  - a. Change Radiation Safety Officers;
  - b. Order byproduct material in excess of the amount, radionuclide or form authorized on the license;
  - c. Add or change the areas or address(es) of use identified in the license application or on the license; or
  - d. Change the name or ownership of your organization.
6. Submit a complete renewal application or termination request at least 30 days before the expiration date on your license. You will receive a reminder notice approximately 90 days before the expiration date. Possession of radioactive material after your license expires is a violation of NRC regulations.

In addition, please note that NRC Form 313 requires the applicant, by signature, to verify that the applicant understands that all statements contained in the application are true and correct to the best of the applicant's knowledge. The signatory for the application should be the licensee or certifying official rather than a consultant. Since the NRC also accepts a letter requesting amendment or renewal of an NRC license, the signatory for such a request should also be the licensee or certifying official rather than a consultant.

NRC will periodically inspect your radiation safety program. Failure to conduct your program according to NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC may result in enforcement action against you. This could include issuance of a notice of violation; imposition of a civil penalty; or an order suspending, modifying, or revoking your license as specified in the NRC Enforcement Policy.
