Haddam Neck Plant Amendment to Indemnity Agreement No. B-32

Connecticut Yankee Atomic Power Company ("CYAPCO") is currently in the process of completing decommissioning activities at the Haddam Neck Plant. As part of decommissioning CY constructed an Independent Spent Fuel Storage Installation (ISFSI) on CYAPCO property but located remotely from the plant site. At this time CY has moved all of its Spent Nuclear Fuel and Greater Than Class C Waste to the ISFSI.

CYAPCO request that the Nuclear Regulatory Commission amend the existing Indemnity Agreement No. B-32 to include the ISFSI and proposes that Item 4 of the Attachment to the Indemnity Agreement be deleted in its entirety and replaced with the following:

Item 4 – Location

All of the premises, including the land and all buildings and structures, of Connecticut Yankee Atomic Power Company's shown and highlighted on Drawing SK-RJ-002-05, Revision 1, dated 9-7-05 (attached hereto and made part hereof). The Connecticut Yankee site is located in the Town of Haddam, Connecticut.

In order to confirm that CYAPCO is maintaining adequate financial protection with respect to any property within the amended definition of "Location" in Item 4 as set forth above, that CYAPCO may transfer to a third party in the future, CYAPCO also requests that the NRC amend Item 5 of the Indemnity Agreement to add the following after the listing of existing insurance policies:

> *Mool* MMSSOI

With respect to property not owned by the licensee which is located at the location described in Item 4 or at the location described in Item 3 of the declarations to the above listed nuclear energy liability insurance policies:

Primary Property and Decontamination Liability Insurance Policy No. P06-048 issued by Nuclear Electric Insurance Limited (or any successor policy thereto).
