I am a medical physicist with certification by the ABMP in therapeutic physics issued in 1997. I have worked as a full-time physicist for over sixteen years and my duties have included RSO or assistant RSO for fourteen of those years. Part of my commitment to the position of RSO has been a detailed study and adherence to the regulations set forth by the NRC regarding medical use of radioisotopes and general radiation safety. I believe experience plays a large role in performing the duties of RSO since many situations arise that are(were) not predicted during classroom teaching or board examination. Therefore, I am concerned with the current proposed rules which do not take into account certification by the ABMP or ABR certificates issued before October 2005. The proposed rules, if passed, will impart an undue burden on myself as well as many of my colleagues to continue practicing in our current or future capacity as medical physicists and/or RSOs. This in turn, will likely create a shortage of medical physicists to perform the role of RSO to implement and adhere to your radiation safety regulations.

I am writing in support of the AAPMs' petition to include a "grandfather" clause to include those previously (pre-10/05) certified by the ABMP and ABR to be able to continue in their professions as RSOs and AMPs.
