The Division of Waste Management and Environmental Protection, Environmental Protection and Performance Assessment Directorate (EPPAD) requests technical assistance from the Division of Fuel Cycle Safety and Safeguards (FCSS) in the completion of the following project:

Project: Review *EnergySolutions'* application for modification to existing U.S. Nuclear Regulatory Commission (NRC) Order for exemption from 10 CFR Part 70 licensing

REQUESTED ACTION: EPPAD requests FCSS support in reviewing *EnergySolutions'* request for NRC authorization to accept for disposal, certain materials derived from the cleanup of the former gaseous diffusion facility located in Oak Ridge, TN. *EnergySolutions* is currently authorized under NRC Order to accept for disposal at its Clive, UT facility, waste containing special nuclear material in greater quantities than specified in 10 CFR Part 150 without obtaining an NRC license pursuant to 10 CFR Part 70.

FCSS is requested to conduct an acceptance review and detailed technical safety review of *EnergySolutions'* submittal of September 29, 2006, as supplemented by additional information provided by letter dated December 4, 2006. Also provided is additional background information from an October 24, 2006, meeting between NRC staff and *EnergySolutions* representatives, held at NRC Headquarters.
