As discussed today, we need approximately two more weeks to finalize the response letter to the IMPEP review findings from the MRB. Our Legislature started session on Monday, January 8, 2007 and our fee bills were read into the record today. We are in the midst of preparing testimony for these bills and completing required Bill Analysis and Fiscal Impacts for this critical legislation.

We also received the 12/21/06 letter from NRC HQ on the final review of our rule compatibility and should be able to complete filing of changes during the first quarter of CY2007. We will also respond to that letter during the week of 1/22-26/07. This should provide the full package of information to complete the IMPEP response picture and begin work on the Action Plan activities.

Danny Loomis and Margaret Lut have both been extremely helpful in working with the RML staff to develop written protocols and policies on licensing and inspections. Good progress is being made to update and finalize these needed guidance documents for the RML program.
