Confirming the verbal authorization provided to Ohio state University Research Foundation on 11/17/06, the purpose of this bilateral modification is to (1) extend the period of performance under the cooperative agreement at no additional cost to the NRC and (2) provide incremental funding in the amount of \$182,062, fully funding the cooperative agreement. This cooperative agreement is hereby modified as follows:

- "1. Extend the period of period of performance from 07/26/2004 through 03/31/07.
2. The agreement's total obligated amount is hereby increased by \$182,062 from \$1,497,425.00 to \$1,679,487.00."

A summary of obligations fo this cooperative agreement, from the award date through the date of this action is provided below:

This modification obligates FY 07 funds in the amount of \$182,062.

All other terms and conditions of the cooperative agreement remain unchanged.
