The purpose of this modification is to deobligate excess funds in the amount of \$9,567.54 from the subject task order, thereby decreasing the obligated amount from \$249,307.76 to \$239,740.22.

Accordingly, the following changes are hereby made:

Under Paragraph 2 of page 2 of the task order award, the cost ceiling is hereby revised to read as follows:

“Task Order 84 shall be in effect from 08/07/2006 through 10/16/2006, with a cost ceiling of \$239,740.22. The amount of \$232,548.01 represents the estimated reimbursable costs, and the amount of \$7,192.21 represents the fixed fee.”

A summary of obligations for this task order, from award date through the date of this action, is given below:
