INTRODUCTION

Pursuant to 10 C.F.R. § 2.702(a) of the Commission's regulations, the Staff of the Nuclear Regulatory Commission (Staff) requests that the Atomic Safety and Licensing Board (Board), designated in the above-captioned proceedings, issue a subpoena, attached hereto, requiring Steven Moffitt, to attend and give testimony at a deposition.

DISCUSSION

The Staff requests the Board to issue a subpoena for Steven Moffitt in order to ensure the Staff's ability to depose this individual on the date specified. Mr. Moffitt's testimony is relevant to the issues raised by this enforcement proceeding. In 2001, Mr. Moffitt was Director of Technical Services at Davis-Besse. In this capacity, Mr. Moffitt was Mr. Geisen's immediate supervisor and interacted with Mr. Geisen on matters related to Davis-Besse's communications to the NRC in the Fall of 2001, which are the subject of the enforcement order against Mr. Geisen.

CONCLUSION

In light of the foregoing, the Staff requests the Board to issue the attached subpoena to Mr. Moffitt.
