Paul,

Tom McLaughlin is out this week, and he has asked me to handle the deer tissue sampling report and your request to dispose of the samples.

I have reviewed the report, "Deer Tissue Sampling Results - Depleted Uranium Impact Area Site Characterization Jefferson Proving Ground, Madison, Indiana." I concur with the Army's conclusion that the Du Impact Area hunting zone, the nearby hunting zones, and the background hunting zones had total uranium concentrations for each deer tissue type that appear to be from the same statistical population. This conclusion is based upon the analytical results from Tables 3-1 through 3-3 of the aforementioned report. Also, no analytical results of any deer tissue type from the three zones indicated the presence of depleted uranium.

The Army can dispose of the deer samples from the above investigation.
