Dear Director Schlueter:

The new year provides opportunity to look forward and to begin resolutions, but if I may, I would like to look backward and make several observations of the achievements of the Kansas Department of Health and Environment, Bureau of Air and Radiation, Radiation Control Section. I do so against the backdrop of attending the Radiation Control Program 2006 Workshop this past December in Topeka.
