This refers to your license amendment request. Enclosed with this letter is the amended license. The high dose-rate remote afterloader (HDR) facility and the depleted uranium storage area may be released for unrestricted use. In addition, as discussed with Ms. Rose Campbell on January 3, 2007, we understand that removal of the depleted uranium from the accelerator was performed under the Radparts.com license. If our understanding is incorrect, please notify us immediately. Please note that Mr. Zhang was also removed from the license during this amendment, since the HDR was removed the license.

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region I Office, Licensing Assistance Team, (610) 337-5239, so that we can provide appropriate corrections and answers.
