To Whom It May Concern:

TetraLogic Pharmaceuticals (TetraLogic) has retained IES Engineers (IES) for the purpose of supervising and documenting the decommissioning of the laboratory facility located at 365 Phoenixville Pike in Malvern, Pennsylvania. TetraLogic is decommissioning because they are moving from 365 Phoenixville Pike to 343 Phoenixville Pike. Please note TetraLogic will not be terminating this license. Rather the new address will be added to the license.

The 365 facility operated under Standard Industrial Classification (SIC) Code 8731 – Research and Development. TetraLogic is a biopharmaceutical company that discovers and develops drugs to treat cancer. TetraLogic is approved for use of  $^3\text{H}$ ,  $^{14}\text{C}$ ,  $^{32}\text{P}$ ,  $^{33}\text{P}$  and  $^{35}\text{S}$ . TetraLogic used only  $^3\text{H}$  at the 365 Phoenixville Pike address and has not used RAM onsite since late May 2005.

Facility swipes and related decommissioning were completed upon termination of RAM work in June 2004. Facility decommissioning in preparation for the move has begun at 365 Phoenixville Pike. Due to the nature of use onsite and the minimal quantities used, decommissioning of the limited RAM use areas will only require efforts currently covered under the materials license.

A radioactive materials waste pick up occurred on June 1, 2005. At that time all radioactive materials were removed from the site. As there has been no radioactive material use since and because decommissioning occurred at that time, TetraLogic does not expect to generate any RAM waste during final decommissioning.

Pursuant to the requirements of 10 CFR 30.36D, TetraLogic is notifying the NRC of our intent to decommission the facility located at 365 Phoenixville Pike in Malvern, Pennsylvania. Decommissioning activities will continue until decommissioning is complete. TetraLogic is scheduled to move from the facility by the end of this month.
