Dear Dr. Ghoniem:

Enclosed is Amendment No. 52 to your NRC Material License No. 13-09649-02 in accordance with your request dated December 21, 2006. Please note that the changes made to your license are printed in **bold** font.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

Please note that we have reformatted Subitem Nos. 6, 7, and/or 9 and Condition No. 12 at this time to remove all references to excluded authorizations, including but not limited to authorizations such as "generators, xenon-133, aerosols, etc."

In accordance with my telephone conversation on January 23, 2007, with Ed Johnston of your staff, you were not added to the NRC license for therapy use of iodine-131 under 10 CFR 35.300. The preceptor form provided with this amendment request did not contain sufficient information to comply with the requirements in 35.390. When this information is available, you may submit a new amendment request.

As discussed with Mr. Johnston, your request to add 3M Model 606C-CA brachytherapy sealed source was in error and should have read 3M Model 6D6C as listed in the Sealed Source and Device Registry. As requested by Mr. Johnston, it reads 6D6C on your NRC license.

Please be advised that Medi-physics Models 6715 and 7000 are brachytherapy devices which house Medi-Physics Model 6711 brachytherapy sources and are not required to be listed on your NRC license.


You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.
