The purpose of this letter is to request an amendment to our Materials License referenced above.

Proposed Request:

Schulz Electric is requesting a modification to Condition 6A of our Radioactive Material License to remove the approved use of Source Material on site.

The reason for the request is due to the fact that Schulz Electric receives motors from commercial nuclear power plants. Any uranium contamination present on the motors would likely fall under the SNM category since commercial reactor fuel is slightly enriched and therefore no longer source material.
