SUBJECT: LEAKING STRONTIUM-90 PLATED SOURCE IDENTIFIED AT UNIVERSITY (UPDATE)

On November 15, 2006, the Princeton University Radiation Safety Officer (RSO) notified the NRC Operations Center that a source containing 180 microcuries of strontium-90 (Sr-90) was found to be leaking on November 13, 2006. The RSO reported that contamination was identified in two rooms in the University's Jadwin Hall where the Sr-90 source was used and stored. Other sealed sources, stored in the same cabinet drawer with the Sr-90 source, were cross-contaminated. No personnel contamination was identified. NRC Region 1 performed a reactive inspection on November 22, 2006, to follow up on the licensee's notification. The two rooms were completely decontaminated. The licensee submitted a written report, in accordance with 10 CFR 30.50(c)(2), on December 15, 2006. On January 31, 2007, a urine bioassay of the only researcher who handled the Sr-90 source confirmed no detectable intake of Sr-90. The leaking source and other sources that were cross-contaminated are packaged for disposal in a configuration that eliminates the potential for further contamination.

The Region 1 Office of Public Affairs is prepared to respond to media inquiries.

The State of New Jersey has been notified. The information is current as of 4:00 p.m., February 1, 2007.
