Dear Ms. Reilly:

On January 25, 2006 AREVA NP Inc. Lynchburg submitted Revision 3 of the ISA Summary for the Mount Athos Road Facility (Reference 1). This submittal was provided as an annual update. On March 22, 2006 additional information was requested by NRC in regards to the January 25, 2006 submittal (Reference 2), and this additional information was submitted by AREVA NP on April 10, 2006 (Reference 3). D. The proprietary information that AREVA NP Inc., requests to be withheld from public disclosure is contained in the entire document(s) as so marked.


