- Tc-99m as stated in your License # 29-30840-01 is duly authorized under 10CFR 35.65 which allows you the Licensee to receive and posses such material for use as calibration, transmission and reference sources only.
- Your License specifically states in Para 4 (b) that <u>you need to request and</u> <u>obtain an amendment before you order byproduct material in excess of the</u> <u>amount, or radionuclide, or form different than authorized on the License.</u>

An amendment to receive and possess material such as unit dose Tc-99m (MDP) should be <u>requested under 10CFR 35.200</u>—Use of byproduct material for imaging and localization studies for which a written directive is not required.

While this may have been an oversight or mis-interpretation of License conditions, Nuclear Diagnostic Products will be unable to supply you with such material until the appropriate amendment is obtained and a copy forwarded to us.
