- In procuring all reasonable funds to facilitate the objectives of our radiation safety program and related regulatory requirements.

Mr. Perna is a medical physics consultant with accounts primarily located throughout Pennsylvania, West Virginia and Ohio. He expects to be routinely on-site an average of 1 - 2 hours per quarter. Given the small size of our nuclear medicine program, this is expected to be more than adequate to meet all of the NRC and PA state regulatory requirements.
