The purpose of this modification is to: (#1) add support for the March 2007 GFES examination to include, examination development (Section C.4.2 Task #2); copying and shipping of the examinations (Section C.4.3 Task #3); examination grading (C.4.4. Task #4); examination evaluation (C.4.5 Task #5); and updating of GFE test item bank files for the NRC Web Site (C.4.7 Task #7), (#2) to extend the duration of the contract through March 31, 2007, (#3) increase the contract ceiling for the base contract by \$36,203.00 from \$935,425.00 to \$971,628, as a result of an increase to the level of effort, and (#4) modify the schedule of costs, as a result of an increase to the level of effort. Accordingly, the contract is modified as follows:

Item #1:

1. Under Section C.4.2, Task #2 - EXAMINATION DEVELOPMENT, the following tasks are hereby added:
  - A. The contractor shall develop a GFES examination (1 BWR and 1 PWR) for March 2007.
  - B. The contractor shall forward a complete draft examination to the NRC by January 22, 2007. The NRC will conduct a review of the examination and provide any comments to the contractor by February 1, 2007.
  - C. The contractor shall incorporate any NRC comments and prepare the final examinations consisting of two forms "A" and "B" of each examination (PWR and BWR) that contain the questions in a different order. The two forms of the final examination for PWR and BWR are due to the NRC by February 12, 2007.
2. Under Section C.4.3, Task #3 - COPYING AND SHIPPING EXAMINATIONS, the following task is hereby added:

The contractor shall ship the March 2007 GFES examination copies, along with blank answer sheets and instructions to the proctors and to their addresses provided by February 27, 2007.
3. Under Section C.4.4, Task #4 - EXAMINATION GRADING, the following task is hereby added:

Final grades for the March 2007 GFES examination shall be forwarded to the NRC PO by March 23, 2007 and to the NRC Regional Offices by March 23, 2007.

4. Under Section C.4.5, Task #5 - ITEM STATISTICS/EXAMINATION EVALUATION, the following task is hereby added:

The contractor shall provide the NRC with three (3) copies of a comprehensive evaluation report for the March 2007 GFES examination by March 31, 2007.

5. Under Section C.4.7, Task #7 - UPDATE AND MAINTAIN THE TEST BANK WEBSITE, the following task is hereby added:

The contractor shall update the GFE test bank files to include the new and validated test items from the March 2007 GFES examination and forward the updated files to the NRC PO and NRC/OIS by March 31, 2007.

6. Under Section F.2.2, Task #2 - EXAMINATION DEVELOPMENT, the following deliverables are hereby added to support the March 2007 GFES examination administration:

- A. Draft PWR GFES is due by January 22, 2007.  
Draft BWR GFES is due by January 22, 2007.

- B. Final PWR GFES Forms "A" and "B" is due by February 12, 2007.  
Final BWR GFES Forms "A" and "B" is due by February 12, 2007.

7. Under Section F.2.3, Task #3 - COPYING AND SHIPPING EXAMINATIONS, the following deliverable is hereby added:

The contractor shall ship the March 2007 GFES examination copies, along with blank answer sheets and instructions to the proctors and to their addresses provided by February 27, 2007.

8. Under Section F.2.4, Task #4 - EXAMINATION GRADING, the following deliverable is hereby added:

Final Grade reports for the March 2007 GFES examination is due to the NRC PO by March 23, 2007 and to the NRC Regional Offices for utility distribution by March 23, 2007.

9. Under Section F.2.5, Task #5 - ITEM STATISTICS/EXAMINATION EVALUATION

Comprehensive item statistics/examination evaluation report for the March 2007 GFES examination is due by March 31, 2007.

10. Under Section F.2.7, Task #7 - UPDATE AND MAINTAIN THE NRC GFE TEST ITEM BANK WEBSITE the following deliverable is hereby added:

Updated GFE test item bank files (PWR and BWR) to include new validated test items for the March 2007 GFES examination is due by March 31, 2007.

11. Under Section F.5, DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE 1 (Jun 1988), delete the first sentence in its entirety and replace with:

The ordering period for this contract shall commence on December 15, 2003 and will expire on March 31, 2007.

Item #3:

12. Under Section B.4, CONSIDERATION AND OBLIGATION - COST PLUS FIXED FEE (JUN 1988) ALTERNATE I (JUN 1991), paragraph a is hereby revised to read as follows:

(a) The total estimated cost to the Government for full performance of this contract is \$971,628.00, of which the sum of \$895,873.00 represents the estimated reimbursable costs, and of which \$75,755.00 represents the fixed fee.

Item #4:
