The purpose of this modification is to:

1). Add the following new NRC Region II Resident Inspector Site (RISE) location to allow for contractor support at no additional cost to the Government*: USNRC, Savannah Operations Office c/o NA266, Building 730-2B, P.O. Box A, Aiken, SC 29802. As a result, the number of REGION II RISE locations is increased from 20 to 21.

**It is understood by mutual agreement of the parties that support for this new location will be provided utilizing existing L-3/GSI staff and within the estimated number of seats (~ 70 Seats) under Region II RISE locations under the task order.*

Accordingly, the task order is hereby modified as follows:

1. Under Subsection C.2.1.1 FACILITIES, paragraph 2. REGIONAL OFFICE LOCATIONS, subparagraph b. is revised to add 1 Resident Inspector Site as follows:
