The following is in response to the deficiencies noted in your fax sent on January 26, 2007 to *EDGE* Solutions, LLC.

**Item #1**

Revised Part I, Section 1.0, paragraph 1.1 to read "All radiography performed under the license to *EDGE* Solutions, LLC will be performed at temporary job sites anywhere in the United States where the NRC maintains jurisdiction."

Added paragraph 1.2 to Part I, Section 1.0 to state, "If radiographic operations are expected to exceed 180 days at a temporary job site, written notice will be provided to the appropriate NRC regional office prior to exceeding the 180 days."

**Item #2**

Revised Part I, Section 2.0 to read "Field Station" rather than Storage Facility and included bullet stating "licensed materials will be dispatched from the storage location".

Revised Part I Table of Content, Section 1.0, subsection 2.0 to read "Field Stations."

AMSHM Model 650L source changer is the source changer we are going to use. See revised "Attachment 1".
