Marvin, Dennis and Beverly,

Wade asked me to address your questions. First, please find attached a newer Adobe Acrobat version of the figure showing the immediate area surrounding Building 235. It is an E-size image with greater resolution. Below are answers to the questions you asked or clarification you sought:

- 1. Bldg 418 (confirm) Yes, the storage building on the back side of Building 235 is Building 418.
- 2. Small box above Bldg. 418 The small box above and to the left of Building 418 (southwest corner of the building) is a small pad site for the air conditioning unit that serves it. The other small box above and to the right of Building 418 (northwest corner of the building) is a slightly larger pad site that has the junction box for the electrical and instrumentation lines that come from the pump house and goes to the cooling tower.
- 3. Aband. Cooling Tower Basin This is the old, abandoned basin for the previous cooling tower that was replaced with the existing tower in 2001.
- 4. Box directly below the Cooling Tower Basin I'm not certain exactly what you are referencing here, but the box immediately adjacent to both cooling towers represents the suction plenum for the respective cooling tower.
- 5. Rad Waste Storage (confirm) Yes, this wing of Building 235 is for Rad Waste Storage.

If you have any more questions or need further clarification, please let me know.
