NRC licensees are required to update their decommissioning and financial assurance documents every 3 years according to 10 CFR 30.35 (see link).

Our records dated 2003 indicated that you were in the process of establishing a Trust Agreement with a local financial institution to cover possible decommissioning costs of your facility. You also stated that Rink International, LLC, will not possess any Kr-85 before the Trust (or another NRC approved financial instrument) were in place.

Please reply to this email confirming:

1. that you are going to send by mail the original Trust Agreement within 7 business days, or
2. inform us that you have not possess any Kr-85 since the issuance of license 11-27756-01 on September 26, 2003.

As a reminder, use Appendix A of NUREG-1757, Vol. 3 as a guidance to submit the appropriate financial assurance documentation.
