## Fitness for Duty Summary

### Management Actions

1. During the six month period ending December 31, 2006, Nuclear Management Company, LLC (NMC) Point Beach Nuclear Plant (PBNP) conducted 595 drug and alcohol tests in accordance with 10 CFR Part 26. Random test rates are as follows:

POOLS	Annual Period Ending 12/31/06
Point Beach Nuclear Plant	54%

For the semi annual reporting period ending December 31, 2006, three (3) workers were denied nuclear access after testing positive for drugs or alcohol. By test type, two (2) pre-access tests and one (1) for-cause test were positive.

#### Pre-Access Positive Tests

One (1) contractor employee tested positive for marijuana.  
One (1) contractor employee tested positive for cocaine.

The individuals listed above were denied access to NMC nuclear facilities.

#### For-Cause Positive

One (1) contractor employee tested positive for alcohol.

The individual listed above was denied access to NMC nuclear facilities.

2. For the semi-annual period ending December 31, 2006, all blind specimens submitted to PBNP's HHS-certified laboratory yielded expected results.
3. NMC has analyzed program performance data for the six-month period ending December 31, 2006, and has revised FFD procedures to incorporate enhancements as indicated by the analysis.

### Reportable Events

There were no reportable events at PBNP, as defined in 10 CFR 26.73(a), during this reporting period.
