Judge Rosenthal has asked me to acknowledge the Board's receipt of your unopposed motion for a seven day extension of the time within which to reply to the Licensee and NRC Staff responses to the hearing request filed on behalf of the New Jersey Department of Environmental Protection. The motion is granted and the reply is thus now due on February 27, 2007. An order memorializing this action will be entered within the next two days.

In addition, Judge Rosenthal has requested that I inform all of the participants in this proceeding that, henceforth, and even if unopposed, motions for extensions of time must be submitted at least one business day before the document in question is due for filing. Strict adherence to this requirement will ensure that the Board has a reasonable opportunity to consider whether a grant of the desired relief is warranted.
