Dear Dr. Gandy:

Enclosed is Amendment No. 57 to your NRC Material License No. 13-09788-01 in accordance with your request dated January 23, 2007. Please note that the changes made to your license are printed in **bold** font.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

Please note that Dr. Scally is not authorized for materials in 10 CRR 35.300 at this time. You requested in letter dated January 23, 2007, that Dr. Scally be listed on your NRC license for 35.300 and 35.400 material. The letter dated January 9, 2007, that you provided from Dr. Razmianfar, Director and Radiation Safety Officer at West Virginia University, specified that Dr. Scally was an authorized user on the University's NRC license for seed implants including I-125 sealed sources and no mention was made concerning 35.300 material. Therefore, Dr. Razmianfar was contacted on February 12, 2007, and he confirmed that Dr. Scally was authorized for 35.400 material; however, not 35.300 material. Therefore, if you wish to add Dr. Scally for 35.300, please provide her training and experience in accordance with 10 CFR 35.390. Please be advise that new preceptor forms are available on the NRC website at www.nrc.gov, under business with NRC, then NRC forms.

Please note that we have reformatted Subitem Nos. 6, 7, and/or 9 and Condition No. 12 at this time to remove all references to excluded authorizations, including but not limited to authorizations such as "generators, xenon-133, aerosols, etc."

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.
