Dear Mr. Hesler:

The purpose of this letter is to acknowledge receipt of your letter dated January 18, 2007, in which you documented completion of the corrective actions you have taken to ensure no similar violations occur in the future in accordance with the Notice of Violation (Notice) that we issued to you on December 19, 2006. Your action consisted of reviewing relevant regulatory and training materials regarding misconduct. You also noted that since you were no longer employed by FirstEnergy Nuclear Operating Company (FENOC), you were unable to provide any additional corrective actions directly related to the engineering change package that was the basis of the violation. You also stated that you recognize your error and accepted full responsibility for your actions.

We have reviewed your actions in response to the Notice. After considering this information, the NRC has concluded no further action is warranted.
