Jonathan,

Please review the attached letter from Qualtest. The dummy sources tested at the Class 6 level for external pressure where tested for leakage in accordance with the hot liquid bubble test in Annex A of ANSI/HPS N43.6-1997 Paragraph A.2.2.2. The External Pressure test was performed by ENVIRON Laboratories L.L.C. This company was contracted by Qualtest to perform the external pressure test because Qualtest did not have testing apparatus capable of achieving these pressures. Once ENVIRON Laboratories tested the two dummy sources (Section 7 of Qualtest Report 05170) the dummy sources where returned to Qualtest and leak tested with the dummy sources tested by Qualtest. The results of the leak tests can be found in Section 6. The date of the leak test occurred on 3/10/2006, the external pressure test was performed on 2/14/06, as indicated in Sections 6 and 7 respectively. I hope this clears up the confusion and we can classify the sources as Class 6 external pressure instead of Class 3.
