Dear Chad and Gary,

I understand that a contract is being awarded for preparation of the Environmental Impact Statement (EIS) for Shieldalloy Metallurgical Corporation's facilities in Newfield, New Jersey and Cambridge, Ohio and presume that you will continue to be the case managers for the sites. In that regard, I must remind you that SMC is under severe legal and financial constraints as a result of the pending Chapter 11 proceeding. We are currently preparing a business plan that could be affected by invoices from the NRC for preparation of the EIS. Also, we will probably need to have the approval of our creditors and/or the Bankruptcy Court for payment of any invoices the NRC submits on account of the EIS.

Accordingly, we request that the NRC or its proposed contractor prepare and submit for review and approval a detailed budget for the EIS to be prepared for each site. Please indicate what amounts are to be billed to SMC, and when these amounts might be incurred.

Further, for the reasons indicated, from this point forward we request that any invoice submitted to SMC on this or any other project include a detailed breakdown of the work performed, each worker's job title and billing rate, showing a daily log of hours billed by each worker, and the work accomplished during those hours. Include original hourly time description or work sheets prepared by each employee as well as summary reports, progress reports and billing statements.

There are numerous reports that have been prepared covering various environmental concerns for each site. To the extent these previous reports can be used, it will reduce the economic burden to SMC for the EIS.

Thank you for your cooperation in this regard. Your assistance will greatly increase our ability to process these invoices.
