Thank you so much for all you help! After discussing the FDA letter regarding shelf life extension for current stockpiles of KI with our Director, Kirk Whatley, Alabama has decided to change their request to extend and then replenish the KI. We would like to extend the shelf life for the 130mg tablets for 2 years (new expiration date of 3/2009) and the 65mg tablets for 3 years (new expiration date of 4/2010). At the end of the extension period, NRC will replenish the distributed Potassium Iodide tablets in Alabama.
