Summary: Related to a phone conversation this morning, I am providing you information that you requested associated with Dr. Mullin's request to terminate our NRC license:

- 1) The two Hewlett-Packard Model Number G1223A ECD cells (Serial Numbers F1886 and F5041) were sent to Agilent Technologies on 31Jan2007; however, delivery to Agilent was delayed by FedEx because of their request for additional paperwork regarding this transaction. See letter by Dr. Mullin and FedEx shipping label on pages 3 and 4 of this fax.
- 2) See letter from Agilent Technologies acknowledging receipt of cells identified in (1) above (page 5 of this fax).
- 3) The last leak test results (31May2001) of cells identified in (1) above are indicated on page 6 of this fax. Both were less than 0.0001 µCi. Per our Radiation Safety Manual, dated 30Jan2004, our sealed sources are leak-checked every 10 years since they are stored and not installed in the gas chromatography instruments.
- 4) I have reviewed Dr. Mullin's leak test results records starting in 1991 and found all results are below NRC's reporting threshold of 0.005 μCi.


