Mike,

I just spoke with Michael DiDonato of Comprehensive Cardiology. The doctors in this group have dissolved their partnership, and half are staying with Comp Cardio; however, it is the half that work in the Langhorne office. The only other location was at 1 Union St, Suite 101, Robbinsville NJ.

However, at the time the license application was submitted, the doctors' group had an administrative office on Klockner Road, used for the mailing address; and the medical development was still being built, and the building was originally to be Washington Blvd but was changed to Union Street. So although item 5 of the Comp Cardio license appears to ask to add the Union Street NJ address...this is the only address they ever worked at, and this is the address that will be authorized on the Mercer Bucks license, for whom the remaining physicians will be working.

So we will need to 1) open a new licensing action for Comp Cardio in Pennsylvania, and the only location to be listed will be the Langhorne office; 2) open a termination action for the Comp Cardio 29-xxxxx-01 license CONCURRENTLY with 3) the amendment of the Mercer Bucks Cardio license.

The same reviewer should take all 3 actions.
