As I have mentioned in previous conversations, the NRC is in the process of evaluating two major actions for the Shieldalloy site. One action concerns Shieldalloy's proposal to dispose of material on site. The NRC is currently evaluating this proposal through the preparation of an environmental impact statement. The other action is Shieldalloy's request for license renewal. Shieldalloy is currently operating under timely renewal, as permitted by 10 CFR 40.43(b) of the Code of Federal Regulations, until NRC completes its evaluation of Shieldalloy's continued operations. To make this determination, the NRC is preparing a Safety Evaluation Report (SER) and an Environmental Assessment (EA). These documents are expected to be completed by mid-summer. Notice of the availability of the EA will be published in the Federal Register.
