
This letter is to notify you that as of February 1, 2007, Dr. Mark D. Wellens has assumed the position of Radiation Safety Officer.

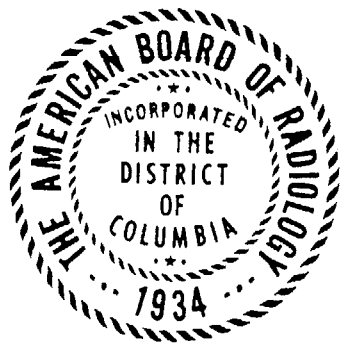
