The Radiological Preparedness Coordinating Committee has completed the review of the updated Illinois Plan for Radiological Accidents (IPRA) – Dresden, Volume II, dated 3/07, site specific to the Dresden Nuclear Power Station.

On January 31, 2007, we received additional changes to (IPRA) – Dresden, Volume II, subsequent to the update you recently were asked to review and comment on. The additional changes, outlined in the attached letter from the State, were reviewed by DHS REP Staff, and a determination was made to not request an additional RAC review of these changes at this time.

The results of both reviews have resulted in our concurrence with the State that there have been no significant changes to the concept of operations for the State of Illinois, Grundy, Kendall, and Will counties, that the revisions do not decrease the effectiveness of the plan, as revised, and that the Plan continues to conform to Title 44 Code of Federal Regulations, Part 350, and the requirements in NUREG-0654.

Enclosed is the final printing of the document dated 3/07, and accompanying maps. Please destroy your old copies of these documents and replace with the enclosed material.

Enclosed is the updated Illinois Plan for Radiological Accidents (IPRA)-Dresden, Volume II, dated 03/07. A line in the right margin indicates all changes made since the 02/05 update.

Since the draft plan was submitted for RAC review, the following changes were made:

- The Illinois Department of Natural Resources section in Chapter 1 has been updated.
- The Civil Air Patrol section in Chapter 1 has been updated and contains extensive changes.
- The Radiological Assessment Team (RAT) has been renamed the Radiological Assessment Field Team (RAFT) throughout the IPRA-Dresden.
- WYKT (105.5 FM) has been added to the appropriate Grundy County sections of the IPRA-Dresden for the purpose of emergency notification to the public.
- Changes have been made to the IPRA-Dresden correlation document per the review document provided by your office.

The concept of operations for the State of Illinois, Grundy, Kendall and Will counties as outlined in the 02/05 IPRA-Dresden have not changed. The revisions to IPRA-Dresden do not decrease the effectiveness of the plan and the plan, as revised, continues to meet the guidance provided by NUREG 0654/FEMA REP-1.

Please consider this the formal submission of the updated IPRA-Dresden to the Regional Assistance Committee. The State, Grundy, Kendall and Will counties will implement the updated IPRA-Dresden during the Dresden exercise on March 21, 2007.
