Subject: ORDERS PROHIBITING INVOLVEMENT IN NRC-LICENSED ACTIVITIES
(IMMEDIATELY EFFECTIVE)

This is to inform the Commission that an Immediately Effective Order Prohibiting Involvement in NRC-Licensed Activities for a period of five years will be issued on or about March 16, 2007, to Mr. James Francis Mattocks for a violation of 10 CFR 50.5, "Deliberate Misconduct." This action is being taken because Mr. Mattocks deliberately removed a Bushmaster .223 caliber M4/A3 assault rifle and thermal imaging scope from the St. Lucie Nuclear Plant, operated by Florida Power and Light. Mr. Mattocks then sold the assault rifle to a member of the St. Lucie community. While Mr. Mattocks is currently incarcerated in the Franklin Correctional Institution, the NRC has no control over when Mr. Mattocks may be released from custody.
