

The purpose of this modification is to (1) exercise Option Period Two in accordance with Section C.5, FAR Clause 52-217-9, "Option to Extend the Term of the Contract (MAR 2000)", thereby extending the period of performance through January 24, 2008 (2) increase the contract ceiling amount by \$199,000.00 from \$375,360.00 to \$574,360.00 (3) incrementally fund this contract by \$199,000.00 from \$352,000.00 to \$551,000.00. Accordingly the Contract is modified as follows:

DURATION OF CONTRACT PERIOD

"The period of performance for this contract shall commence on January 25, 2005 and will expire on January 24, 2008"

CONSIDERATION AND OBLIGATION CEILING

"The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$574,360.00"
