The purpose of this modification is to increase the obligated amount in the contract by \$44,083.00, from \$640,720.00 to \$684,803.00, to cover the additional labor costs, audio/visual costs and other direct costs associated with the Quadripartite Meeting which took place in October, 2006. Accordingly, the contract is hereby modified:

Section B, Subsection B.2 Consideration and Obligation, paragraph (b), first sentence, is deleted and substituted with the following in lieu thereof:

“(b) The amount presently obligated with respect to this contract is \$684,803.00.”
