Please process an amendment to the above referenced radioactive materials license in order to:

1. Add the following location of use:

Abbey Medical Center, 2nd Floor
Delaware Route 4, White Clay Creek Hundred
New Castle County, DE 19808**

A facility diagram is attached for your review. This is a newly constructed office and this space was not previously listed on any radioactive material licenses. The nuclear medicine rooms are to be located in a corner on the second floor of the building. We expect the facility to be operational in April. When this facility is open, we will transfer all of the equipment and materials from our facility at:

to the Abbey Medical Center location. We will then perform a close-out of the Newark facility. At that time we will process an amendment to remove the Newark location of use from the license.

All other aspects of our program will remain the same.


We will also notify the DE Office of Radiation Control concerning this change.


