

14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)  
The purpose of this modification is to provide incremental funding in the amount of \$4,420.00, thereby increasing the obligated amount under TASK ORDER 001 from \$315,000.00 to \$319,420.00. Accordingly TASK ORDER 001 is modified as follows:  
1. Under Section A.2 CONSIDERATION AND OBLIGATION--COST REIMBURSEMENT (JUN 1988), the first sentence of paragraph (b) is DELETED entirely and REPLACED by the following:  
"(b) The amount obligated by the Government with respect to this contract is \$319,420.00."  
  
All other terms and conditions remain unchanged, including the ceiling amount of \$334,972.51.  
  
This modification obligates FY2007 funds in the amount of \$4,420.00.

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
