The purpose of this modification is to exercise Option Year three of the contract, thereby increasing the ceiling amount of the contract by \$109,800.00, from \$259,750.00 to \$369,550.00; and extend the period of performance of the contract from February 20, 2007 through February 19, 2008. Accordingly, the contract is hereby modified:

1. Section B, Subsection B.5 CONSIDERATION AND OBLIGATION, paragraph (a), first sentence, is deleted in its entirety and substituted with the following in lieu thereof:

"The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$469,550.00."

2. Section B, Subsection B.8 DESCRIPTION/SPECIFICATIONS/WORK STATEMENT, paragraph IX, PERIOD OF PERFORMANCE, is deleted in its entirety and substituted with the following thereof:

"The period of performance of this contract is February 20, 2004 through February 19, 2008."
