Emergency planning, radiological protection and environmental review kickoff meeting*

Radiation protection

1. Discussion of which Regulatory Guides or Industrial Guides that MOX Services has committed to complete or complete in part.
2. Discussion of a cross walk with commitments from the Construction Authorization to the Safety Evaluation Report, License Application and the Integrated Safety Assessment Summary.

Emergency procedures

1. Discussion of the evaluation as a stand-alone document and the need to contain supporting information.
2. Discussion of commitments in the radiation protection chapter to have emergency procedures for workers as part of their radiation protection procedures.
3. Discussion of commitments to be part of the Savannah River Site (SRS) emergency plan.
4. Discussion of the inputs and assumptions used by MOX Services in determining the off-site dose to meet the 1 Rem limit.
5. Discussion of management measures to ensure that the assumptions in the Emergency Plan Evaluation remain valid.

1. Discussion of any changes to facility design that may impact the Final Environmental Impact Statement that was prepared at the time the Construction Authorization was issued.
2. Discussion of supporting information for air sampling locations for environmental surveillance.
3. Discussion of commitments for sampling plans for environmental monitoring and surveillance.
4. Discussion of how trend analysis is going to be incorporated into ALARA Committee review and cross-referenced into Chapter 9 of the License Application.
