RE: Docket No. PRM-51-10 – Support the Massachusetts Attorney General's Petition for Rulemaking- Spent Fuel

Dear Sir or Madame:

Greenpeace wholeheartedly supports the Massachusetts Attorney General's Petition for Rulemaking on Spent Fuel. Specifically we support the Attorney General's position that the Nuclear Regulatory Commission should:

(1) Consider new and significant information showing that NRC incorrectly characterized the environmental impacts of spent fuel storage as insignificant,

(2) Revoke the regulations that codify the incorrect conclusion and excuse the NRC's failure to consider spent fuel storage impacts in the licensing process,

(3) Issue a generic determination that the environmental impacts of high-density pool storage of spent fuel are significant, and

(4) Order that any NRC licensing decision that approves high-density pool storage of spent fuel at a nuclear power plant or any other facility must be accompanied by an EIS that addresses: (a) the environmental impacts of high-density pool storage of spent fuel at that nuclear plant and (b) a reasonable array of alternatives for avoiding or mitigating those impacts.

Greenpeace believes that this rule change is necessary to protect the public health and safety. We also believe that there is significant new information since the attacks of September 11th that warrant this change. It is both a credit to the Commonwealth and an embarrassment to the NRC and congressional oversight that this proposed rule is even necessary more than 5 years later. The Commission should move expeditiously to ensure that the Commonwealth's proposed rule is promulgated.
