First, thank you for the opportunity to comment on the Draft EA for Decommissioning the Mukilteo Research Station (your October 13, 2006 letter to Gary Robertson). Our staff reviewed your draft and provided the following statement for your use:

"The Washington State Department of Health has reviewed the EA and concludes that the decision to release the facility for unrestricted use is appropriate if, as stated in the EA, the DCLGs selected meet the screening criteria provided in NUREG 1757 and the surveys performed by the licensee showed levels less than the selected DCLGs as is also stated in the EA."
