My name is Christian Araguas and I am the project manager at the Nuclear Regulatory Commission in charge of the safety review of the early site permit (ESP) application submitted by Southern Nuclear Operating Company (SNC) for the Vogtle site. This email is to request that you release to Bechtel, the percentage of hazardous materials transported for the purposes of preparing an early site permit (ESP) application. Currently Bechtel is the contractor for SNC, hired to assist in the preparation of the ESP application for the Vogtle site. On August 15, 2006, the Nuclear Regulatory Commission (NRC) received an application from SNC for an ESP at the Vogtle site and has since began its review of this application. To support the NRC staff's ability to conduct a confirmatory analysis of the potential hazards posed to the site, the percentage of hazardous materials transported needs to be made available to Bechtel so that it can be referenced in the ESP application.
