Dear: Sir or Madam,

Covance Central Laboratory Services (Covance CLS) would like to amend our current NRC License (13-26058-01) in the following manner:

1. Current Radiation Safety Officer (RSO), Dr. Harvey Kincaid will be temporarily relocated to another Covance CLS laboratory in the near future. As such, we request that Daniel J. Hall, MT (ASCP), Immunology Supervising Technologist, be considered as the new Radiation Safety Officer (RSO). Mr. Hall has been employed at Covance CLS for 9 years. He received his initial radiation safety training at Covance in July 1998 and has attended the annual radiation safety refresher training since that time. Since becoming a Senior Technologist in December 2000, he has been given the responsibility of reviewing contamination surveys, radioactive material inventory and removal of radioactive waste under the supervision of the current RSO.
2. In addition to Mr. Hall, we wish to add another Authorized User to those individuals currently listed on our license who supervise the use of licensed material. This individual and her relevant training is as follows:
  - a. Cheryl Grove, MT (ASCP) – Cheryl has 2 years experience at Covance CLS working with both <sup>125</sup>I and <sup>3</sup>H. Prior to Covance CLS, Cheryl had 9 years experience working with radionuclides at Bristol Myers Squibb. Cheryl is the Senior Technologist over the RIA area of Immunology.
3. We would also request that the following individual's names be deleted from the list of Authorized Users on our license, as they are no longer working with licensed material:

  - b. Carol Hill
  - c. Melissa Tomczak
